







PARENT/LEGAL GUARDIAN'S STATEMENT AND CONSENT TO CHILD'S PARTICIPATION IN COMPETITION

I, the undersigned, hereby declare that I consent to my child's participation:

Associations (Polish Karate Union, Polish Kickboxing Association, Polish Olympic Taekwondo Association

Kickboxing Federation, European Judo Union, European Taekwondo Union) and World Sports Federations
(World Federation Karate, The World Association of Kickboxing Organizations, International Judo
Federation, World Taekwondo). I take full responsibility for their involvement and agree for my child to
comply with the Organizational Regulations, EUSA Regulations, World Sports Federations regulations,
Anti-Doping regulations, and local regulations

- 1) I acknowledge that the declared sport is a contact sport and carries inherent risks. I understand that the organizers (AZS Warsaw and EUSA) have implemented preventive measures to reduce the likelihood of physical injury, but there is no guarantee that my child will not sustain an injury.
- 2) I declare, at my own and sole risk and for the safety of my child and all event participants, the following:
 - My child has no medical contraindications, and their state of health allows them to participate in the competition.
 - My child meets all the requirements for participation in the event.
 - My child does not live with anyone who belongs to a health risk group. Otherwise, I acknowledge my child's participation in the event is at my own and sole risk.
- 3) I have read, understood, and agree for my child to abide by the Organizational Regulations, EUSA Regulations, regulations of World Sports Federations, Anti-Doping regulations, and local regulations. I understand and unconditionally agree that failure to comply with any of these regulations may result in the revocation of my child's accreditation and their exclusion from the competition.
- 4) I voluntarily agree to assume all the above risks and accept sole responsibility for any injuries, illnesses, damages, losses, claims, liabilities, or costs of any kind that my child may experience or incur in connection with their participation in the EUC Combat sports.
- 5) On my own behalf and on behalf of my child, I hereby release, undertake not to sue, and hold harmless the event organizers, their employees, agents, and representatives from any and all claims, including any liability, actions, damages, costs, or expenses of any kind that may arise from or be related to this event.
- 6) I confirm that my child has international general liability and accident insurance, which I will produce upon request. Failure to do so will result in my child's inability to participate in the event.
- 7) I authorize the Organizing Committee to use my child's image (photos, videos) and their name and surname as a competitor/registered participant in sporting events and publications related to the declared discipline within the framework of this event.
