









DECLARATION

I accept responsibility for participating in the European Universities Combat Championships 2025, organized by the University Sports Association in Warsaw in cooperation with the European University Sports Association, Polish Sports Associations (Polish Karate Union, Polish Kickboxing Association, Polish Olympic Taekwondo Association, Polish Judo Association), European Sports Federations (European Karate Federation, WAKO European Kickboxing Federation, European Judo Union, European Taekwondo Union) and World Sports Federations (World Federation Karate, The World Association of Kickboxing Organizations, International Judo Federation, World Taekwondo) and for complying with the Organizational Regulations of the OC, EUSA Regulations, regulations of World Sports Federations, Anti-Doping regulations approved by World Sports Federations and local regulations.

- 1) I hereby acknowledge that the sport declared by me is a contact sport that carries inherent risks, and that AZS Warsaw and EUSA have implemented preventative measures and policies to reduce the likelihood of physical injury. However, there is no guarantee that I will not suffer injury.
- 2) I hereby declare, at my own and sole risk and for my own safety and the safety of all persons participating in the event, that:
 - a) I declare that there are no medical contraindications and my state of health allows me to take part in the competition. In the case of a minor participant,
 - b) I meet all requirements for participation in the Event and do not belong to any health risk groups,
 - c) I do not live with anyone who belongs to a health risk group, and if so, I participate in the Event at my own and sole risk.
- 3) I have read, understood, and agree to abide by the Organizational Regulations of the OC, EUSA Regulations, regulations of World Sports Federations, Anti-Doping regulations approved by World Sports Federations and local regulations. Furthermore, I understand and unconditionally agree that failure to comply with any of these regulations may result in the revocation of my official accreditation for the event.
- 4) I voluntarily agree to assume all of the above risks and accept sole responsibility for any injuries (including, but not limited to, bodily injury, disability, and death), illness, damages, losses, claims, liabilities, or costs of any kind that I may experience or incur in connection with my participation in the aforementioned event.
- 5) On my own behalf, I hereby release, undertake not to sue, indemnify, and hold harmless the event organizers, their employees, agents, and representatives from any and all claims, including any liability, actions, damages, costs, or expenses of any kind arising from or related to this event.
- 6) I confirm that I have international general liability and accident insurance, which I must produce upon request. Failure to do so will result in my inability to participate in the event.
- 7) I authorize the Organizing Committee to take and use photographs (photos, videos) and my name and surname as a competitor or registered participant in sporting events and publications related to the declared discipline within the framework of this event.
